Dick Hahn submitted quotes he had received from both State Farm and Farmers Insurance Companies which showed lower premium costs. In order to better understand the actual coverage being proposed by each insurance company the board has requested the committee to obtain detailed proposals from each of the insurance companies. The Insurance Review Committee will report back to the board when the collection and analysis of the proposal data is complete and it is ready to make recommendations to the Board.
