 - b) Review of Article VI, sections K & L: In sect. K the wording of the CC&R. No consensus on changing sect. K, but there was agreement that it was too vague. On section L, a motion was approved to change the allowed parking time from two overnights to four overnights. Also, the second sentence needs to be changed to reflect the latest city code.
